The Odisha Govt. Ayurvedic Physician's Association and Homeopathic Service Association are demanding / requesting time and again for change of designation of the post of Inspector of Ayurveda and Inspector of Homoeopathy in the state.

The matter of renaming/ change of designation of the post of Inspector of Ayurveda and Inspector of Homoeopathy was under active consideration of Govt. for some time past.

The Inspector of Ayurveda and Inspector of Homoeopathy are the district functionaries in the rank of Class-I (Jr.) Branch. They have been performing duties and responsibilities of supervising the work and functions of Govt. Ayurveda, Homoeopathy and Unani Dispensaries at district level like their counter parts i.e. Chief District Medical Officer under Allopathy system of the State.

In order to improve the work efficiency of supervising Officers at district level, now, therefore, Govt. after careful consideration, have been pleased to change the designation of the post of "Inspector of Ayurveda" and "Inspector of Homoeopathy" as "District Ayurveda Medical Officer" and "District Homoeopathy Medical Officer" respectively.

This shall come into force from the date of issue of this Resolution.
